AT OUR NOVEMBER 12 MEETING AT BUFFALO PRESBYTERIAN CHURCH, WE HEARD FROM PHOTO-JOURNALIST AND AUTHOR WAYNE DRUMHELLER. HE RELATED LORE REGARDING THE CULTIVATION AND USE OF APPLES AT THE TIME OF THE AMERICAN REVOLUTION. HE POINTED OUT HOW THE CONTINENTAL ARMY DEPENDED ON RATIONS OF APPLE CIDER AND VINEGAR. WAYNE BROUGHT A SAMPLE OF AN APPLE WHICH TYPICALLY WOULD HAVE BEEN GROWN IN THE 1700'S IN NORTH CAROLINA. IT'S SIZE, SHAPE AND AROMA WERE DISTINCTLY DIFFERENT THAN OUR MODERN "APPLES".
